Sub: Fixation of Uniform Fee Structure for PG Medical/Dental Courses in Private Unaided Medical/Dental Colleges in Andhra Pradesh–Request to fix uniform

fee for 85% of Seats – Reg.

With reference to the above subject, I am to bring to your kind notice that, the Hon'ble Supreme Court of India in its pronouncements in TMA Pai case vide ref 1 supra dealt with the admissions into Private Un-Aided Non-Minority Higher Education institutions& directed that the Fee should be common for all category of students. 15% of seats with higher fee may be fixed for NRI Quota.

The Hon'ble Supreme Court has confirmed the above ruling in PA Inamdar Judgement and in Islamic Academy Judgement.

Hon'ble AP High court vide ref 4 supra has directed AFRC to decide the issue of uniform fee structure and non-categorization of seats duly taking into note the pronouncements of SCI referred to above.

It is to inform further that the Hon'ble High Court of AP in a Judgement rendered by Justice. Goda Raghuram in ref 5 supra has directed that the fee should be common for 85% of seats and a higher fee may be fixed for 15% of NRI Quota Seats.

In pursuance to the aforesaid judgements, AFRC (Now APHERMC) has been following uniform fee structure and non-categorization of seats in Engineering, Polytechnic and other higher education institutions, except medical institutions.

We also like to bring to your notice that almost all the states in the country are following the rulings of the Apex Court by fixing the common fee for 85% of the Seats and fixing the higher fee for 15% of NRI Quota Seats. Hence, we request you to fix common fee for 85% of the seats and higher fee for 15% of NRI Quota Seats.

We further submit that the fee fixation shall be as per the audited expenditure of the Institution submitted to Income Tax Department. While calculating the fee, the APHERMC should also take into consideration of increment allowable expenditure i.e. increase from March 2018 to March 2019 and increment for allowable salaries @9.27%, Furtherance @15% and also inflation @15.76% as these were considered for last many years in the case of Engineering, Pharmacy and other PG courses. Treat the matter as most urgent as the last date for admissions issued by Medical Council of India is fast approaching. If an order fixing the common fee structure is not considered, the Association will be constrained to withdraw the letter of consent issued to the Government for seat sharing. Pending finalization of fee fixation, we request you not to admit students to the convener quota in our member institutions
