With reference to the above subject, it is brought to your kind notice that, as per Medical Council of India Regulations on Post Graduate Medical Education, the Post Graduate students shall be paid Stipend.

Basing upon this one, the Government of Andhra Pradesh issued Orders on payment of Stipend to Post Graduate students.

It is submitted that, the fee fixed for Post Graduates shall include the expenditure incurred on payment of Stipend to Post Graduate students. Even the other states such as Maharastra has considered the payment of stipend as expenditure on the college. If the payment of stipend is not considered as expenditure it is very difficult for the survival of the institutions and it is not financial viable.

Hence, we request you to consider the stipend also for fixing the fee for Post Graduate Medical and Dental Education.
